**NOTIFICATION**

In pursuance of the recommendation of the District Health Officer, District Korangi, via letter No.DHO/DKK/-10793/96, Dated 21.11.2020, regarding emerging hotspots with respect to the spread of COVID-19 and the powers conferred in Section 3 (3) of the Sindh Epidemic Diseases Act, 2014 (Sindh Act No.VIII of 2015), it is hereby ordered that a micro smart lockdown is to be enforced in the specified area as following for a period of two weeks i.e. **21-11-2020 to 05-12-2020**.

**The following Standards Operating Procedures (SOPs) shall be enforced in this respect:**

- i) Anyone entering or exiting the lockdown area shall wear a mask without any exception.
- ii) Movement of people residing in areas under lockdown shall be strictly restricted.
- iii) Only grocery shops/convenience stores and pharmacies shall be allowed to remain open in these areas during specific timings as specified in the Home Department's Order No. SO(H-I)HD/8-1(04)/2020-Corona, dated 1<sup>st</sup> June, 2020.
- iv) Only one person of household shall be allowed outside for buying food items and medicines by displaying original CNIC to the law enforcement agencies.
- v) Only one attendant, where extremely necessary, shall be allowed with a person in need of medical care.
- vi) No private/family get-together will be allowed in private homes.

- vii) District Administration will make every effort to provide ration to the needy people residing in these areas through philanthropic organizations or by employing its own resources.
- viii) District Administration will make every effort to provide medical assistance to the households. In case required.
- ix) The lockdown shall be operational from **07:00 pm** on **21-11-2020**. It will remain effective till **05-12-2020 at 07:00 pm** or till the infected persons are cured as per guidelines issued by the government.

The Assistant Commissioners Sub-Division Korangi, Shah Faisal & Model Colony are directed to provide logistic support in order to implement this micro smart lockdown in close coordination with the Health Department and law enforcement agencies (Police and Rangers) in the above-mentioned UCs.

The Assistant Commissioners Sub-Division Korangi, Shah Faisal & Model Colony shall ensure proper lockdown security plan in coordination with the respective Superintendent of Police.

The Assistant Commissioners Sub-Division Korangi, Shah Faisal & Model Colony are further directed to make implementation plans and enforce the above orders in letter and spirit, penalize the violators under the directives of Home Department's order No.SO(J-I)HD/8-1(04)/2020-Corona dated: 01-06-2020 and take further decisions in coordination with the concerned Superintendent of Police to resolve day-to-day issues in the public interest.
