**NOTIFICATION**

**No.DC/South/COVID-19/7566/2020:** In pursuance of the recommendation of the District Health Officer of District South, Karachi via letter No.DHO/DSK/2768/69 dated 20-11-2020 regarding micro hotspots with respect to the spread of COVID-19 and the powers conferred in Section 3(3) of the Sindh Epidemic Diseases Act, 2014 (Sindh Act No.VIII of 2015), it is hereby ordered that a micro smart lockdown is to be enforced in the streets/localities of the specified areas in these sub-divisions until active cases come down to zero.

**The following Standards Operating Procedures (SOPs) shall be enforced in this respect:**

- i) Anyone entering or exiting the lockdown area shall wear a mask without any exception.
- ii) Unnecessary movement of people residing in areas under lockdown shall be restricted.
- iii) All businesses shall ensure COVID-19 SOPs are followed in letter and spirit.
- iv) No private/family get-together will be allowed in private homes.
- v) No gatherings of 3 or more persons shall be allowed in public spaces.
- vi) All persons who are positive shall be quarantined at their houses and would not be allowed to mix with others unless they test negative.
- vii) Government will make every effort to provide ration to the needy people residing in these areas through philanthropic organizations and by employing its own resources.

- viii) Government will make every effort to provide mobile dispensaries and mobile utility stores in these areas.
- ix) The micro smart lockdown shall be operational until active cases in the area come down to zero.

Assistant Commissioner, Civil Lines is directed to provide logistic support in order to implement this lockdown in close coordination with the Health Department and law enforcement agencies (Police and Rangers) in the above-mentioned areas.

Assistant Commissioner, Civil Lines shall ensure proper lockdown security plan in coordination with the respective Superintendent of Police.

Assistant Commissioner, Civil Lines shall also ensure to take onboard the Municipal Commissioner, DMC, Union Councils, Members of Peace Committees and renowned philanthropists of the localities.

Assistant Commissioner, Civil Lines is further directed to make implementation plans and enforce the above orders in letter and spirit, penalize the violators under the directives of Home Department's order No.SO(J-I)HD/8-1(04)/2020-Corona dated: 01-06-2020 and No.SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 06-11-2020 and further take decisions in coordination with the concerned Superintendent of Police to resolve day-to-day issues in the public interest.
